- \$1,000,000 per occurrence/\$3,000,000 aggregate for Professional Liability coverage — Separate Limit
- \$1,000,000 per occurrence/\$3,000,000 aggregate for General Liability coverage — Separate Limit
- \$1,000,000 per occurrence/\$3,000,000 aggregate for Employee Benefits Liability coverage — Separate Limit
- \$1,000,000 each accident for Hired and Non-Owned Auto Liability — Separate Limit
- \$25,000 per occurrence/\$25,000 aggregate Evacuation Expense Reimbursement — Separate Limit
- \$25,000 per occurrence/\$25,000 aggregate Public Relations Expense Reimbursement — Separate Limit
- \$1,000 per occurrence/\$3,000 aggregate Patient Loss of Property Reimbursement — Separate Limit
- \$250,000 per occurrence/\$250,000 aggregate for HIPAA Violations Coverage is included in the General Liability limit
